DG GROW responds to the President's column in the December 2020 issue of the **Voice of EFCA**.

The Head of Unit 'Circular economy and construction' emphasises that '*the Commission will examine whether the national recovery and resilient plans reflect the proposal to deliver a massive building renovation plan appropriately*'.

The **Digitalisation and BIM Committee** welcomed two guests at its virtual meeting on 19 January 2021.

Mark Baldwin presented the BuildingSMART International Professional Certification. Committee Vice-Chair commented that international standardised training and global common understanding are a useful step forward to standardise BIM knowledge and the certification process.

Ian Pritchard and Peter Sørensen, representing ACE (Architects' Council of Europe), agreed to take forward joint initiatives to ensure portability and interoperability of software services, prevent loss of control over the data and eliminate unfavourable licence agreements.

The European Commission (EC) more and more focuses development efforts on facilitating European sustainable development investments. The EC wishes to be more visible on the geopolitical scene and strengthen its policies abroad. It is decreasing its involvement in the implementation of projects, particularly in infrastructure, energy and cities.

Consequently, the **European External Aid Committee** will shift its focus on the institutions that actually implement financial investments, i.e. the European banks and Member States Development Agencies.

However, actions with regard to the ongoing review of the 2020 PRAG (Procedures and Practical Guide), current misinterpretations and possible mistakes are continued.
