


#### Distribution of Consulting Services contracts – aggregated amount by region (2017-2020)


Total amount 2017-2020 : 674,867 k€



## Evolution of consulting services contracts financed by AFD (number & aggregated amounts, 2017-2020)




#### Distribution of Consulting Services contracts by sector (% of total amount, 2017-2020)

(% of total amount per year, 2017-2020)




European firms are awarded most international consulting services contracts, by far

A valuable European expertise particularly in health, water and sanitation, agriculture and food security sectors.





## PROCUREMENT / THE STANDARD SCENARIO




#### GENERAL PRINCIPLES

- Procurement processes must follow International Good Practices:
  - Equity
  - o Openness
  - Transparency







- AFD is accountable for:
  - The efficient use of its funds
  - Its reputation (no Prohibited Practices)
- AFD provides untied aid since 2002

#### **AFD'S PROCUREMENT GUIDELINES**

 Procurement processes must comply with the Beneficiary's applicable laws and regulations, as well as AFD's Guidelines.

- There is a number of eligibility criteria (Prohibited Practices – conflict of interest, fraud/corruption..., Sanctions Lists, debarment by the World Bank, embargos...)
- A competitive process is the rule

#### THE SELECTION PROCESS



- Direct Shortlist, or Request for Expressions of Interest (REOI)
- Request for Proposals (RFP)
- Award of the contract to the highest scored Consultant (combined technical and financial score)
- Technical score > Financial Score (e.g. 80%-20%)




- Large competition through an Open



#### **ESHS CLAUSES**

In the Works and DBO SBDs

#### WHY?

- To avoid negative impacts on the environment, and on people; to limit delays and overcosts
- To award the contracts with a strong ESHS impact to skilled and responsible contractors
- To ensure a level-playing field

#### **During works execution**

- Financing of ESHS measures
- Ensuring implementation of ESHS clauses
- Sanctions to be applied in case ESHS measures are not correctly implemented





#### **CLAUSES ON SECURITY**


For Works and Consulting Services contracts

#### WHY?

- To ensure firms take security risks into account (for both people and goods) in orange and red zones (French Ministry of Foreign Affairs)
- To award contracts to skilled and responsible firms
- To encourage firms to submit bids even in these zones

#### **During works execution**

- Security Plan required to be implemented
- Financing of security measures
- The firm has the option to suspend the services in case of imminent danger



#### **TAXES**

For Consulting Services – Request for Proposals and Contract

#### Why?

- To clarify which taxes exactly shall be excluded in the financial evaluation
- To identify applicable taxes locally, and which Party shall be liable for their payment:
  - VAT
  - Withholding Tax
  - Contract Registration Fees
  - Customs duties (if applicable)
