New EIB funding tool: EU-Ukraine Gateway Trust Fund

EIB €1.59 billion financial assistance, supported by guarantees from the EU budget

20/06/2022: EC and EIB launch two new models for setting up financing instruments combining grants and loans in support of the objectives of **REPowerEU** and **New European Bauhaus**

21/06/2022: provisional political agreement on the **corporate sustainability reporting directive** (CSRD). EP plenary vote in autumn

23/06/2022: the **Data Governance Act** enters into force.

Following a 15-month grace period, it will be applicable from September 2023. The Data Act is setting rules regarding the use of data generated by Internet of Things (IoT) devices

24/06/2022: contract procedures for EU External Action - A practical guide applicable to any procedure to be launched as of 24 June 2022 (**PRAG 2021.1**)

27/06/2022: the Council adopts its negotiating position (general approaches) on the **renewable energies directive** and the **energy efficiency directive**. The Council and the Parliament will now enter interinstitutional negotiations to agree on the final text of the two directives

29/06/2022: EU invests €5.4 billion to support key transport infrastructure projects across the continent

30/06/2022: provisional political agreement between the Council and the European Parliament on the **Foreign Subsidies Regulation**. The regulation aims to remedy the distortions created by subsidies granted by non-EU countries to companies operating in the EU's single market

05/07/2022: EP adopts the **Digital Services Act** (DSA) and **Digital Markets Act** (DMA), i.e. a regulation on online platforms. On 18 July, the Council adopted the DMA (and is expected to adopt the DSA in September)

05/07/2022: EC presents new **European Innovation Agenda**

08/07/2022: The Netherlands submits its national **recovery and resilience plan**. The EC has now received 27 recovery and resilience plans.

12/07/2022: EU finance ministers give the go-ahead for €1 billion in financial help to Ukraine

14/07/2022: provisional political agreement on the 2030 policy programme '**Path to the Digital Decade**'

15/07/2022: publication Taxonomy Delegated Act - to include specific nuclear and gas energy activities, under certain conditions, in the list of environmentally sustainable economic activities covered by the so-called **EU Taxonomy**. The Regulation enters into force on 1 January 2023

18/07/2022: proposal for a **Nature Restoration** Law

20/07/2022: '**Safe Gas for a Safe -Winter**' Plan

22/07/2022: proposed flexibilities to continue **European Neighbourhood** cross border and **Interreg** transnational cooperation programmes

25/07/2022: Romania will receive €31.5 billion in **cohesion funds** from the EU for the 2021-2027 period.

27/07/2022: revised **TEN-T** proposal to reflect impacts on infrastructure of Russia's war of aggression against Ukraine

09/08/2022: EU regulation stipulating that Member States "shall use their best efforts" to **reduce** their **gas demand** by 15% (compared to their average consumption in the past five years) between 1 August 2022 and 31 March 2023, enters into force

12/08/2022: adoption Multi-annual strategy for the **Interreg** NEXT programmes
